We can use Newton's second law to estimate the forces involved in situations such as a car crash: Consider a passenger of mass 60 kg travelling in a car at a speed of 20 m/s (about 50 mph). The vehicle is involved in a collision, which brings the car (and the passengers) to a halt in 0.1 seconds.
