### **How to cite . . . - Bluebook Legal Citation - Tarlton Law ...**

Bluebook rule 18.2.1 (a) explains: "When an authenticated, official, or exact copy of a source is available online, citation can be made as if to the original print source (without any URL information appended)." This rule goes on to define "authenticated documents," "official versions," and "exact copies."

### **5 Tips for Citing Web-Based Sources in Legal Writing - Law ...**

The precise format of a case citation depends on a number of factors, including the jurisdiction, court, and type of case. You should review the rest of this section on citing cases (and the relevant rules in The Bluebook) before trying to format a case citation for the first time. However, the basic format of a case citation is as follows:

If the citation only refers to part of the sentence, place the citation within the sentence immediately after the fact supported by the cite. Assuming the sentence contains two cites, place the period for the second citation after the parenthesis to emphasize that the second cite refers to the latter half of the sentence.
