The NJ JAM is approved to award 1.5 credits of jurisprudence to meet this requirement.

To perform expanded functions under the direct supervision of a licensed dentist in the state of New Jersey, dental assistants must be licensed by the New Jersey State Board of Dentistry as a Registered Dental Assistant (RDA). To register as an RDA, one must: 1. Successfully complete high school or its equivalent, AND 2.

This exam is administered through the Joint Commission on National Dental Examinations (JCNDE) who has to approve applications. There are 2 parts to this exam: Written part with 350 questions; Practical, with at least 12 patients
