The style of all writs and process shall be "The State of Texas;" and unless otherwise specially provided by law or these rules every such writ and process shall be directed to any sheriff or any constable within the State of Texas, shall be made returnable on the Monday next after expiration of twenty days from the date of service thereof, and shall be dated and attested by the clerk with the seal of the court impressed thereon; and the date of issuance shall be noted thereon.

Rule 15. Writs and Process (1941)

Courts issued writs under common law to allow people to proceed with a legal action. Writs are also used to direct other courts and public authorities. Courts generally use writs to grant extraordinary relief to party, to grant the right of appeal, or to grant the sheriff the right for seizure of property.

A business check or money order made out to the Indian River County Sheriff's Office for \$40.00 for non-enforceable civil process (such as summons, subpoenas, etc.) or \$90.00 for enforceable process (such as writs of possession or replevin). Sheriffs now attend at election petitions and are responsible for the execution of writs; they are liable for the safe custody of prisoners, and they act as returning officer at parliamentary elections. Collection Process on Writs of Execution. A Writ of Execution is a court order that commands the Sheriff to levy on the property of a debtor for the satisfaction of a debt. You must give the Sheriff's Office a letter of instruction describing the property to be seized or the action to be taken. You must provide the service information.
